

**KINNELON VOLUNTEER ANIMAL SHELTER (KVAS)
VOLUNTEER/FOSTER AGREEMENT**

In consideration of this opportunity to volunteer/foster at the Kinnelon Volunteer Animal Shelter, I, (Print Name) _____, agree to the following terms and conditions, intending to be legally bound by them:

1. I understand that KVAS is a charitable and non, profit organization providing care to cats and other animals that might come into their care. I will abide by the mission, rules, regulations, policies and programs of KVAS, as established from time to time, while I am a volunteer.
2. I certify that I am at least 21 years of age and understand that as a volunteer I am not an employee of KVAS.
3. I agree to be supervised by a KVAS officer(s), manager(s) and/or their designee(s).
4. I agree to work as a team member with all KVAS volunteers.
5. I agree to volunteer for a minimum of three (3) months unless I am terminated from KVAS.
6. I understand that animals are not predictable, and their behavior cannot be guaranteed by anyone. I assume the risks of being bitten, scratched, injured, or frightened by cats, kittens, dogs, puppies or other animals in connection with my volunteer work for the Kinnelon Volunteer Animal Shelter.
7. I agree that the Borough of Kinnelon is not liable to me for any injuries, damages, liabilities, losses, judgments, costs, or expenses whatsoever that I might suffer or sustain in connection with the performance of my volunteer activities for the Kinnelon Volunteer Animal Shelter.
8. I agree that KVAS is not liable to me for any injuries, damages, liabilities, losses, judgments, costs, or expenses whatsoever that I might suffer or sustain in connection with the performance of my volunteer activities for the Kinnelon Volunteer Animal Shelter.
9. I hereby indemnify, defend, and hold the Kinnelon Volunteer Animal Shelter and the Borough of Kinnelon harmless from and against any claims, lawsuits, injuries, damages, losses, costs, or expense whatsoever sustained by any animal or any person in connection with the performance of volunteer activities for KVAS or my breach of the Kinnelon Volunteer Animal Shelter's rules, regulations, policies, programs, etc.
10. I agree to treat all animals, other volunteers and the general public with dignity and respect at all times.
11. I understand that as a volunteer, no one can accompany me into the shelter to assist in my shift, view KVAS animals, or for any other reason who is not an approved KVAS volunteer and who has not executed a Volunteer Agreement.
12. I understand that the private combination number or any key or locking device that allows access to the shelter facility is private, privileged and not to be shared with any non, KVAS volunteer and I specifically agree not to share same except as permitted herein. Divulging such information will cause harm to KVAS and/or the Borough of Kinnelon, for which I agree to assume all responsibility in the event of any breach.
13. I understand that any pets owned by me should be current and up, to, date on all vaccinations. I should consult my veterinarian as to what precautions I should take to protect my pets.

14. I understand that KVAS recommends that I consult a physician regarding a tetanus shot and/or other protective vaccinations etc.
15. I agree to immediately report to a KVAS Manager, any KVAS animal that shows aggression, abnormal behavior or bites.
16. I understand that I may be dismissed as a volunteer for failing to abide by any of the items above.

I understand and agree with this Volunteer Agreement which replaces all prior versions. I understand that I am not approved as a KVAS volunteer until this Agreement is approved in writing. I will receive a copy of this signed Agreement, if requested.
